Matters arising:

- SoF Review – panel meetings going well, end Wednesday 10 August. Reasonable amount of tweaking with a view to formatting the recommendations for action and use in our Annual Plan submissions. Lots of discussion around protecting our Greenbelt from property development. Incorporating wording respectful of mana whenua, particularly in the introduction. Community Forum set for 28 September.

Further follow-up with Council regarding Coronet Forest, good engagement and still looking like following our suggestion. Likely site visit as next step.

Great evening at the Coronet Peak Re-forestation event. Large turn out with a mix of people. Most off the focus is on replanting the front face of Coronet Peak Station, likely planting day of 10,000 native trees 15 October, look to raise profile closer to the time. Big plans for the whole station over time, and work with places such as Otago Uni in developing better methods of planting. Ben and Graeme also there.

Clean Air

The ORC ULEB testing has finished – there were 7 volunteers which was a good response. Sarah Harrison is very grateful to the volunteers and Arrowtown community for being so engaged in the issue. We will have the results in a few more months after the analysis is finished. The only other update is Vanessa Hammond from SDHB presented her recent research results to ORC a few weeks ago. It was well received and was used to introduce the timeframe for the Air Plan review.
